Investigation Reveals Physics and Patented Hardware Behind Covert U.S. Spacetime Weapon Used in MH370 Disappearance

These patents, aggressively pushed through the USPTO by a senior Navy technology executive, established the government's foundational IP in this domain. Concurrently, patents from the "gray track," such as Richard Banduric's patent for a "propulsion system... interacting complex electric fields," describe the specific hardware for generating and controlling the powerful, structured electromagnetic fields necessary to manage and synchronize the multiple plasma orb platforms.

1. The Banduric Patent: A Propellant-less Maneuvering System

Technical Explanation: Richard Banduric's patent, "Interacting Complex Electric Fields and Static Electric Fields to Effect Motion," describes a revolutionary propellant-less drive system. The core claim is a method for producing an action force where the reaction force is

perpendicular to it, a clear departure from Newtonian physics. This is achieved by interacting the "relative velocity electric field" or "acceleration generated electric field" of a moving charged object with the static electric field of a second charged object in a different inertial frame of reference. This aligns with the "New Electrodynamics" framework being explored by the NSF-sponsored "gray track" cohort, which posits that a more complete formulation of Maxwell's equations allows for the generation of force by manipulating scalar and vector potentials. The patent is, in essence, a blueprint for a device that creates thrust by pushing against the fundamental scalar field of spacetime itself.

2. The Pais Patent: The Spacetime Curvature Engine

Technical Explanation: Dr. Salvatore Pais's work, particularly the patent for the "Inertial Mass Reduction Device," describes the physics of the core reactor within each FRC orb. The patent claims that by subjecting an electrically charged system to "accelerated high frequency spin coupled with accelerated high frequency vibration," it is possible to create a "local polarized vacuum".
